

## CONFIRMO COOKIES POLICY

**Last Updated: 30 December 2025**

### 1. Introduction and Scope of This Policy

- 1.1. This Cookies Policy clarifies rules regarding the purpose of using Cookies and informing the user about their purpose on the website [confirmo.com](https://confirmo.com) and related websites (“Site”). Please read the following carefully to understand our views and practices regarding Cookies and how we treat them. This Policy should be read along with our Privacy Policy that informs you how we process personal data in general, which is also available on the Site. - 1.2. The provider of the Site is Confirmo Group and its entities as specified in the Privacy Policy (“Provider”).

### 2. Cookies

- 2.1. Cookies are short .txt files created by a web server and saved via the browser on a user’s computer device. Cookies are widely used by the majority of websites. On a subsequent website visit, the browser sends a saved Cookie back to the server, enabling the server to get all the information saved during the last visit.
- 2.2. Cookies enable the analysis of the number of visits, social media functionalities, the protection of users’ data, the creation of personalized content and marketing communication, and other features. The Provider can thus display targeted information and marketing content.
- 2.3. In addition to Cookies, the Provider uses a web data warehouse. The web data warehouse stores voluminous data in the browser, where the data can be processed by JavaScript. The local data warehouse is usually used to boost website functionalities and remember the user’s preferences.
- 2.4. Furthermore, the Provider uses web beacons. These small images (which are not Cookies) are located on the website and can be used to gather information from the users’ devices. These are usually used to test websites, determine the location of the user on the website, to obtain a read receipt, or as complementary information to the information obtained from Cookies.

### **3. Types of Cookies**

- 3.1. Different types of Cookies are in place for different time periods – the data preservation period. Cookies can be permanent or temporary (meaning either the period during which the browser is running, or a period defined in the browser settings). Permanent Cookies help identify the user's device during the website visit and prevent displaying content repeatedly. Temporary Cookies are deleted automatically when the browser shuts down. They enable the saving of certain data so that the user does not have to fill in certain data repeatedly. Cookies can be deleted at any time regardless of whether they are permanent or temporary. The specific time period of each Cookie is stated in the list of Cookies used by the Provider in the column "Expiration" below.
- 3.2. Types of Cookies used by the Provider:
  - 3.2.1. Necessary Cookies ensure basic technical functioning of the website, i.e. Signing In, using the Service etc.;
  - 3.2.2. Preferences Cookies ensure the creation of personalized content and the saving of preferences, such as language;
  - 3.2.3. Statistics Cookies generate anonymous statistics about website usage; and
  - 3.2.4. Marketing Cookies target adverts on returning users.
- 3.3. Beside their own Cookies, the Provider uses third-party Cookies needed for statistical data on the number of visits, gaining relevant marketing information, making the contents of other websites accessible (such as YouTube), and making their own marketing activities more effective (such as Surveillance Cookies, Optimization Cookies and Partner Cookies).
- 3.4. The Provider never places confidential or private data into Cookies. The Provider can place the User ID into Cookies. This in no way enables third parties to identify the user.
- 3.5. Websites using this type of technology:
  - 3.5.1. Google Analytics maintained by Google, Inc.; Google, Inc. uses the information from Cookies for the purposes of analyzing website visits and informing the Provider in order for it to provide other services concerning the activities on the website and using the internet in general. Google, Inc. can also transfer this information over to third parties should it be required by law, or should third parties process the information for Google, Inc. Information about website usage, together with the Cookies contents, will be stored by Google, Inc. on servers in the USA.

3.5.2. Google Analytics extends its scope to cover advertising functions, specifically:

- The number of displays in the advertising network of Google, Inc.;
- Remarketing (adverts displayed based on visited products);
- Extended demographic overviews (anonymous demographic data reporting); and
- User ID – a Google Analytics function which allows to measure and analyze user behavior across devices. User ID is a series of numbers and letters and never uses personal data that would allow a third party to identify a user.

3.6. Cookies are integrated into internet browsers. When set to default, the majority of browsers automatically accept Cookies. Cookies can be rejected or limited to certain types on the Site.

## 5. Functional Cookies

5.1. This type of Cookies is used to identify devices accessing the website recurrently. They enable the creation of personalized content and the storing of user preferences (i.e. username, language, geographic location, etc.).

## 6. Analytics Cookies

6.1. This type of Cookies is used mainly to monitor the number of visits, to identify how the users browses the website, and which sections they visit. This type of Cookies does not gather information that could identify a user. The Provider constantly improves the functionality of the website by using this type of instrument. The obtained statistics serve to enhance the user experience.

## 7. Advertisement Cookies

7.1. This type of Cookies is used for monitoring the number of visits on the Provider's website, third-party websites (the Provider's contractual advertising partners), and for monitoring hyperlinks used by the user when moving between websites, i.e. redirection from other websites to the Provider's website and vice versa. Such information serves to adjust the Provider's website according to user interests and may also be occasionally shared with third parties, i.e. social network providers, enabling the transmission of the content of the Provider's website into the user's social network. Deleting or restricting this type of Cookies may cause the user to be shown adverts (of the Provider's contractual parties) which do not match their interests.

- 8.1. There may be hyperlinks on the Provider's website redirecting the user to other websites. Such websites are outside the Provider's control. Such websites will usually have their own privacy policies; the Provider recommends that the user familiarize themselves with these policies. The Provider is not responsible for the information, material, products or services contained or accessible from such websites, or for personal data processing on such websites.
- 8.2. The Provider cooperates with third parties which may use Cookies or similar technologies for the purposes of displaying advertisements in relation to the user's previous activities and their interests. For this reason, the Cookies of third parties are saved on the user's device when browsing such websites. - 8.3. The website also contains a Facebook social network plugin (Facebook Inc., 1601 Willow Road, Menlo Park, California, 94025, USA), through which the user can share the website content with their friends or contacts. The Facebook plugin is labelled with the Facebook logo. This plugin connects the user with the Provider's profile on the Facebook server. Facebook gains information that the user visited the website from their IP address.
- 8.4. The Provider makes it clear they do not maintain the above-mentioned plugin and are therefore not responsible for either personal data processing by its provider, or the plugin's proper functioning or potential damages. The Provider also makes it clear they do not receive any information about the data gathered and its further utilization. The Provider is not familiar with the purpose and the scope of data gathered by Facebook. ## **9. Final Provisions**

- 9.1. The Provider is only entitled to share data gathered by Cookies on the basis of fulfilling contracts with third parties or on the basis of complying with regulations. The Provider shares only the minimum data necessary for providing third-party services. These third parties are usually those who:
  - 9.1.1. Participate in a contractual relationship (i.e. accountants and tax advisors, providers of payment and banking services, etc.);
  - 9.1.2. Participate in website maintenance, mail services, cloud services or other services connected with these services;
  - 9.1.3. Are responsible for marketing services;
  - 9.1.4. Are advertisement contract owners.
